THE PROTEST: STUDENTS AND TEACHERS TAKE A STAND

Thousands of SSC aspirants and teachers gathered in Delhi—at Jantar Mantar, DoPT and the SSC office—to demand accountability from the Staff Selection Commission. The call “Delhi Chalo” echoed across the protest zones :contentReference[oaicite:3]{index=3}.

POLICE CRACKDOWN: TEACHERS DETAINED & AGGRESSIVE TACTICS

Many aspirants feel that vacancy announcements are not truly meant for the deserving, but structured in a way that certain groups benefit. This perception adds to existing mistrust in a process that already seems rigged and unfair.

GOVERNMENT RESPONSIBILITY & ACCOUNTABILITY

The onus is on SSC and the central government to ensure fair and transparent exam conduct. If exams are repeatedly canceled or conducted improperly, citizens must have the freedom to protest and demand answers. Any attempt to silence dissent undermines democratic values.

WHAT LEADERS & OFFICIALS HAVE SAID

Anti-SSC protests have sparked public and media attention nationwide under tags like #SSCMisManagement, #SSCVendorFailure, and #SSCSystemSudharo. However, SSC and government officials have yet to issue a detailed public response or show concrete corrective action :contentReference[oaicite:8]{index=8}.
